Developments and enhancements to the Transparency Platform

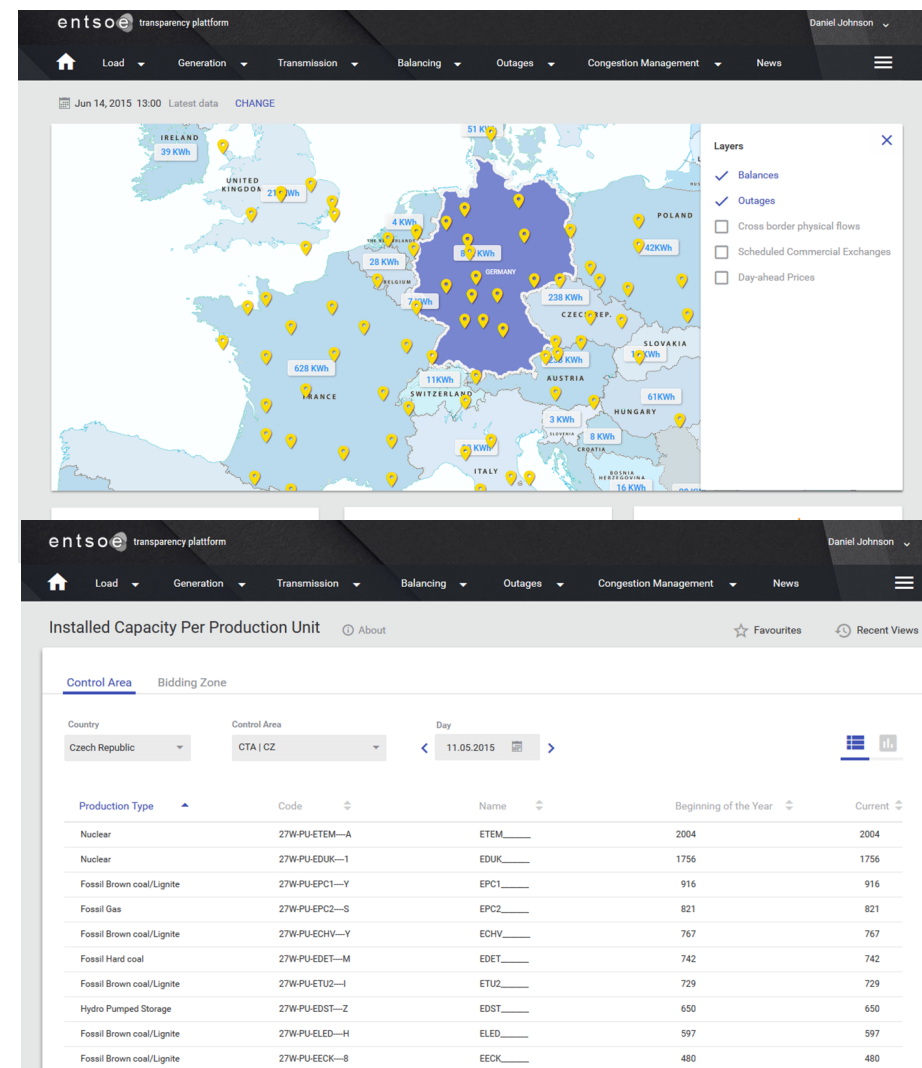
Graphical User Interface

A list of quick wins has been agreed following also the recommendations of the User Group

- Remembering country and time-settings
- Browser compatibility
- Optimizing the screen display

The developments shall be available in the first release of the Platform for 2016 (planned for late January/ beginning of February)

ENTSO-E is assessing the opportunity to build a new UI



Improvements in the Data Extraction Functionalities

Expressed needs

- Simplify M2M Connection
- Combine data in extracts
- Cross reference of data
- Ad-hoc access to commonly used data
- Upgraded subscription module

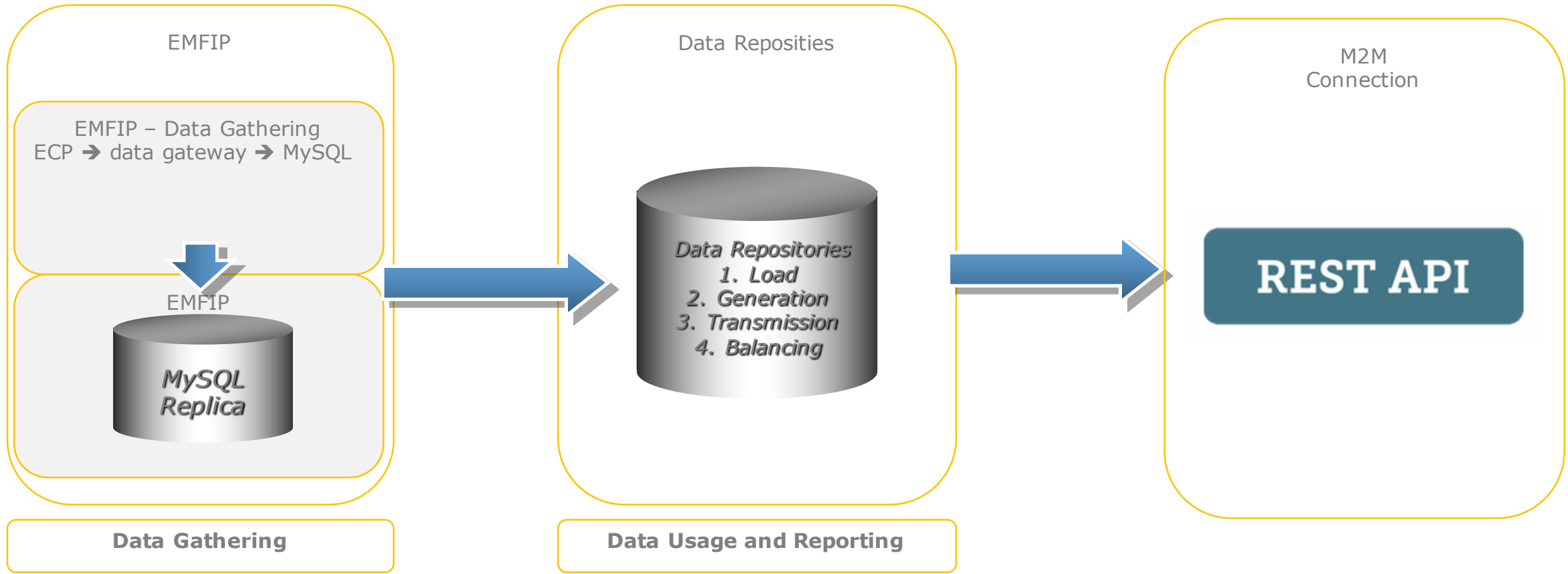
Operating Efficiency

- Lower maintenance and hosting costs
- Improved performance
- More stable environment
- Reduced number of data extract modules

-  Data Extraction

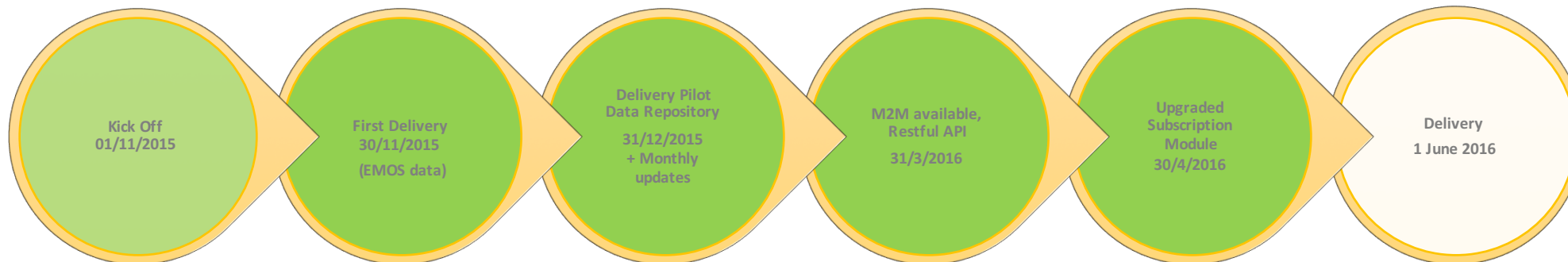


Improvements in the Data Extraction Functionalities

- Deliverables

- Data Repositories 4 areas: load, generation , transmission, balancing
- Deliver most popular data
- Ad hoc Access to data repository through API
- Subscription module
- Restful API with access to subscribers

- Implementation timeline: 1 November-1 June



Update on the progress in data completeness and quality

Data completeness

- Following the decisions of the last AESAG meeting 2 reports were submitted to ACER
 - One report on aggregated information per data item in July
 - Second report with information per data item and data provider in September
- ENTSO-E registered as RRM for reporting under REMIT IA and started reporting to ACER on 7 October
- The technical issues encountered in the first phase of reporting seem to be solved - Success rate of files submitted >90%
- Based on the results of the checks, the provision of data to the Platform reached 90% in Q4 2015

Update on the progress in data completeness and quality

Data quality

- A data quality proposal would also imply changes to the technical documentation of the TP
- This is a task for ENTSO-E following the 1st year after the GoLive of the Platform
- The revision of the documents started with a workshop on 21-22 January 2016
- The updated MoP will be submitted to ACER for an opinion
- This planning would allow enough time for individual projects to be planned and implemented

Concluding remarks

- Developments in GUI to be implemented soon
- The solution on data downloads will be delivered on a step-wise approach
- The developed download facility will make use of data repositories and the REST API
- The solution represents a significant amount of the yearly budget
- Data completeness reached 90%
- Work on reviewing the documentation is ongoing
 - The ENTSO-E User Group is being informed on the ongoing developments
